79 APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllrs R Ford and P Major.

80 DECLARATIONS OF INTEREST

There were no declarations of interest.

81 MINUTES – 4th NOVEMBER 2019 MEETING

RESOLVED: Members resolved that the minutes of the Parish Council meeting held on 4th November 2019 be approved as a correct record and signed by the Chairman.

82 MATTERS ARISING

The following matters were raised from the minutes: -

- Cappers Lane – it was reported that the issue had been reported to Cheshire East Council
- Potholes – reported that Brindley Lea Lane (outside Brindley Lea Farm) is in state of disrepair
- Willbank Lane – it was reported that the road surface was in a very poor state
- Flooding – it was reported that there was flooding outside Seven Oaks Farm – the water made the bank fall away (Hearns Lane)
- Payphone – it was reported that the payphone outside Faddiley House had been adopted by the CHB Trust – this is being investigated
- Baddiley Trust – the Clerk wrote to the representative on the Trust
- Road signs – reported as needing cleaning (40 mph signs in the parish)

83 PUBLIC QUESTION TIME

Four members of the public were present at the meeting and made the following comments: -

- Flooding issue at Burland – no further information had been received (it was stated that it could be around 4-6 months before further information was provided). Fields now drained
- Potholes – it was reported that many more were appearing and need to be reported. SD agreed to undertake a site visit

Next step will be to invite Burland to a meeting with Brindley and Faddiley and go back to the MP once this has been done.

88 PLANNING MATTERS

88.1 Planning Applications

19/5538N Sprout Riding, Long Lane, Burland CW5 8NF

The application was for open fronted timber framed garage and outbuildings.

Members considered the application and had no objections.

19/5790N Brindley Hall Farm, Brindley Hall Road, Brindley CW5 8JA

This application was for a single-storey extension.

Members had no objections.

19/5810N Land between Dragon Cottage and Sydney Cottage, Wrexham Road

This application was for the construction of three detached dwellings with garages.

Members noted that a similar application was turned down a few years ago. Members asked that access is all right and made points about traffic in the area. It was asked whether any S.106/CIL monies are available.
